Dear neighbor,

As your new member of Congress, I have been working hard and across the aisle these last few months to change business as usual in Washington.

I share your frustrations with Congress. The partisanship, bickering, and inaction on our major problems – it's just not right.

I've been encouraged, however, that there are others like me in Congress, especially newly-elected members, who want to work together to find real solutions for our country's most pressing problems. It will take a while, but I'm hopeful that we're laying the groundwork for better days ahead.

"No Budget No Pay" and Balancing the Budget

Passing the "No Budget, No Pay Act" was a good first step. In January, I helped lead the fight to pass this bill which holds Congress accountable – if Congress can't do its job, it shouldn't get paid. We owe it to our children and each other to responsibly balance our budget and put our country on stronger financial footing. Budget gimmicks like the sequester – automatic across-the-board cuts imposed when Congress failed to act – hurt San Diego.

Ensuring Veterans get the Support They Deserve

Making sure that we deliver on our promises to our veterans has never been more important. To date, I've cosponsored over 20 pieces of legislation to improve service delivery to our veterans and their families, and I've introduced my own bill – H.R. 1714, the Shelter our Servicemembers Act – which helps to combat homelessness among San Diego's veterans. I've also helped local veterans and their families claim hundreds of thousands of dollars in benefits veterans had earned with their sacrifice but had been backlogged or lost.

Growing San Diego's Economy, Creating New Jobs

In San Diego, our military is responsible for one of every four jobs and our innovation economy has produced the second largest life sciences technology cluster in the United States. I am honored to serve on both the House Armed Services Committee and the House Science, Space, and Technology Committee where I can more directly push for projects and policies that benefit San Diego.



Strengthening the “Violence Against Women Act”

In February, when reauthorization of the Violence Against Women Act was in doubt, I fought for both passage and improvement of the bill. I’m proud that the version signed into law had bipartisan support and included provisions to protect a woman, regardless of her heritage or sexual orientation, from domestic violence.

Getting Results, Taking an Independent View and Keeping in Touch with You

Since being sworn into office in January, I’ve joined my colleagues in advocating for passage of almost 100 bills, helped over 150 people resolve issues with the federal government, and was recognized by the National Journal as one of the most independent members of Congress. I’ve also been busy attending community meetings around San Diego – along with hosting my own – to make sure I’m hearing from you and representing your voice in Congress.
